Wisconsin Indianhead Technical College students accepted into this program are required to have Caregiver Background and/or Criminal History checks at the state and/or national levels. These checks are run after the student has been admitted into their program and before the start of specific coursework or entering clinical agencies. Results from these checks for students admitted to these programs *may*:

- Prevent enrollment, participation, and/or admission in coursework required for graduation
- Affect ability to secure employment in the field of study upon graduation

Advanced Emergency Medical Technician (A-EMT) and Emergency Medical Technician (EMT) - A Wisconsin caregiver background check is run after the A-EMT or EMT orientation which is usually held one week prior to the start of the classes. Prior to the first day of the class, all Caregiver Background Checks are reviewed by the EMS Teaching Specialist. Clinical agencies review the background check findings for every A-EMT and EMT class as well.

If a record of conviction or pending charges exist, the EMS Teaching Specialist will notify the student that as a result of the background check, the student may be unable to complete the mandated clinical requirements and will be unable to complete the EMT/Advanced EMT program.

WITC is not responsible, nor makes the decision, if you are unable to obtain your training permit. That determination is by the State of Wisconsin Department of Health Services (DHS) and the Department of Justice (DOJ).

If the student and/or their funding agency elects to withdraw the student from the program prior to the first class session, a 100% refund will be given. If the student and/or student's funding agency opts to remain in the course pending a DHS review, any course drop made after the first class session will result in a partial refund as defined by WTCS statute.
