

**ARTICULATION AGREEMENT  
for transfer of credits between**

**The University of Wisconsin-Superior  
Bachelor of Science Degree in Business Administration Finance Concentration  
and the**

**Wisconsin Indianhead Technical College  
Finance Associate of Applied Science Degree**

***Introduction and Rationale:***

The University of Wisconsin-Superior maintains an educational partnership with Wisconsin State Colleges and Universities to provide opportunities for students to enter bachelor's degree completion programs. In the interest of fostering cooperation between our institutions, and to better serve the transfer of students from Wisconsin Indianhead Technical College to the University of Wisconsin-Superior, the faculty and administration of our institutions have established this articulation agreement.

This Agreement specifies the transfer of credit from the Wisconsin Indianhead Technical College Associate Degree named above to the UW-S Bachelor's Degree named above in recognition that the WITC program prepares students for admission to this Bachelor's degree program. The underlying assumption for this Agreement is that the college provides a foundation of occupational courses and the University provides the upper-level courses required within the Bachelor's degree program.

WITC students who successfully complete the Finance Associate of Applied Science degree wishing to transfer to the University of Wisconsin-Superior will be awarded the following credits toward a B.S. Degree in Business Administration.

<sup>1</sup> Credit awarded for Marketing Principles will only transfer as BUS 370 if the student passes an advanced Marketing elective at UWS with a grade of C- or higher.

<sup>2</sup> Credit awarded for Principles of Finance will only transfer as FIN 320 if the student passes FIN 321 at UWS with a grade of C- or higher.

<sup>3</sup> Oral/Interpersonal Communication satisfies the COMM 110 requirement. Students taking only Speech will need to take COMM 110 after transfer to UWS.

**Requirements:**

Students from WITC must have completed the above-named Associate of Applied Science Degree program with a cumulative grade point average of at least 2.3/4.0 for consideration for transfer under the terms of this document. Students must complete the following courses or their equivalents with a grade point average of at least 2.0 with no grade lower than C-: ITS 108; ACCT 200, 201; BUS 270; ECON 250, 251.

WITC general studies/breadth courses in communications, humanities, social sciences, mathematics and natural science may transfer in to fulfill UW-Superior general education requirements in these areas. All UW-Superior general education core and knowledge category requirements not met by transfer credits must be completed.

Students must complete both BUS 270 Business Statistics and MATH 151 Business Calculus or their equivalents.

Students may satisfy UWS' Diversity and Non-Western requirements (3 credits each) by taking qualifying General Education courses.

Elective courses taken at WITC which are not listed in this agreement will be reviewed by the faculty of the UW-Superior degree program named above on a case by case basis

60 credits within the major are required to complete the comprehensive degree named above.

Students must maintain a 2.0/4.0 grade point average in upper division courses to be eligible for the bachelor's degree named above.

Students are required to complete a final project (Senior Experience) to fulfill graduation requirements for the bachelor's degree named above.

**Degree Requirements:** In order to be awarded a degree from UW-Superior, students are required to earn:

- 120 total credits to complete the bachelor's degree named above,
- at least 30 credits at UW-Superior,
- at least 36 credits in upper-division courses (300-400 level), and
- their final 12 credits at UW-Superior .

***Conditions:***

The terms of this degree completion agreement apply only for the purposes of entry to the Bachelor of Science Degree in Business Administration at the University of Wisconsin-Superior.

Credits will be awarded only to students who complete a bachelor's degree at UW-Superior in the degree indicated in this agreement.

WITC students seeking admission to other degree programs offered at UW-Superior may transfer to the University only those credits recognized by the desired program of entry.


This agreement is limited to University requirements for completion of a Bachelor's degree only. Students seeking certification for licensure in particular fields must complete any additional requirements for such certification.

The transferability of credits as put forth within this articulation agreement is advisory. Students who matriculate to UW-Superior are subject to the degree requirements in effect in the students' catalog of entry at UW-Superior.






