

**Amended Program-to-Program Transfer Agreement  
Between  
Wisconsin Technical College System  
Associate of Applied Science (AAS) Degree in Early Childhood Education  
And  
University of Wisconsin Oshkosh  
College of Education and Human Services Professional Education Program  
Bachelor of Science Education (BSE) Baccalaureate Degree  
Licensure in  
Early Childhood to Middle Childhood (EC-MC)  
Or Dual Licensure in  
Early Childhood/Early Childhood Special Education (PreK-Grade 3 and  
Special Education Birth-Age 8)**

**Purpose:** To update the existing transfer agreement between the Wisconsin Technical College System (WTCS) AAS Degree in Early Childhood Education and the University of Wisconsin Oshkosh (UWO) BSE Degree in the Professional Education Program (PEP) with licensure in Early Childhood to Middle Childhood (EC-MC).

**Expected Outcome:** The goal of this agreement is to further refine the existing system of transfer for early childhood professionals completing an associate's degree within the Wisconsin Technical College System as they transition into the Bachelor of Science in Education and teacher licensure program at the University of Wisconsin Oshkosh. The agreement coordinates the competency based portfolio assessment system that exists at the University of Wisconsin Oshkosh with Fox Valley Technical College to develop consistency between institutions for students. Fox Valley Technical College (FVTC) will serve as our partner in this initiative; however, this program will be expanded to all 16 institutions in the Wisconsin Technical College System.

**University of Wisconsin Oshkosh Admission Requirements:**

Wisconsin Technical College students must also meet University of Wisconsin Oshkosh Admission Requirements. UWO reviews official transcripts from all post-secondary institutions attended. UWO can accept transfer credits from accredited institutions only. If a student has transferred credits from a non-accredited institution to a WTCS program, those credits will not be accepted at UWO and will need to be completed at WTCS.

**Program-to-Program Transfer Requirements:**

WTCS students who have successfully completed an AAS Degree in Early Childhood Education wishing to transfer to UWO will meet the following requirements toward the BSE in Elementary Education with licensure in Early Childhood to Middle Childhood (EC-MC).

1) Students transferring general education courses from WTCS to UWO will be given credit for meeting all UWO general education requirements with the following exceptions:

- a. WTCS students are required to complete the math placement exam at time of admission to UWO. Students will need to take any required remedial math courses before completing the 9 required general education mathematics credits. It is recommended that these credits be completed early in the student's program.

Math 110, 211, and 217 (9 credits)

- b. WTCS students are required to complete 3 credits in history at UWO. It is recommended that these credits be completed early in the student's program.

History 101 or 102 or 201 or 202

- c. WTCS students are required to complete 4 credits of biology with a lab and 4 credits of one other natural science with a lab. Up to 4 credits may be transferred in. It is recommended that these credits be completed early in the student's program.

Four credits Biology

Four credits in Chemistry, Geography, Physical Science, or Physics/Astronomy

NOTE: By completing one of the following UWO courses: Biology 104, Chemistry 103 or Geology 150, students are able to fulfill both a Natural Science with a Lab Requirement and the Conservation/Environmental Requirement.

- d. WTCS students are required to complete one literature course (3 credits). It is recommended that this course be completed early in the student's program.

- e. WTCS students are required to complete the UWO course Art 203. It is recommended that this course be completed early in the students program.
  - f. WTCS students are required to complete one additional Humanities course. It is recommended that this course be completed early in the students program.
  - g. WTCS students are required to complete three credits in Non-Western Culture. It is recommended that these credits be completed early in the student's program.
- 2) If WTCS students have not completed licensure requirements as part of their AAS general education course work, those will need to be completed at WTCS or UWO. General Education Requirements as listed in Chapter PI 34 Teacher Education Program Approval and Licenses include:
- (a) Written and oral communication. Oral communication needs to be equivalent to Communication 111, Fundamentals of Speech Communication with a grade of "C" or better. This will be met by 10-801-198 Speech or 10-801-196 Oral Interpersonal Communication
  - (b) Mathematics, as described above.
  - (c) Fine arts.
  - (d) Social science. History course as described above; one course each from two different social science areas including Anthropology, Economics, Geography, Political Science, Psychology or Sociology.
  - (e) Biological and physical sciences with labs. Minimum of eight credits as described above.
  - (f) The humanities, including Literature, Art 203, and one course chosen from Music, Philosophy, Religious Studies, Theatre, or Foreign Language.
  - (g) Western and non-western history or contemporary culture.
  - (h) Wisconsin's model academic standards.

NOTE: Students will still need to register for 12 credits of student teaching.

4) Students will be admitted to COEHS PEP upon satisfying these requirements:

a) Students must meet state requirements for passage of the PRAXIS I: Pre-Professional Skills Tests (PPST).

Reading 175    Writing 174    Math 173

b) Students must demonstrate a C or better in Communications 96, Intro to Oral Interpersonal Communications taken at WTCS.

c) Students must have achieved a minimum 2.75 cumulative gpa from coursework at WTCS. A 3.0 cumulative gpa is preferred.

d) Students must submit results of a clear TB test taken at the Radford Health Center or through their own physician.

e) Students must submit a completed disclosure form and a receipt for a Criminal Background Check (can be purchased from the Cashier's Office in Dempsey 130).

Reminder: Issuance of any license by the Wisconsin Department of Public Instruction is conditional upon the receipt of a satisfactory background investigation. (Sec. 118.19(10)(e), Wis. Stats.) All information received from the Federal Bureau of Investigation and the Wisconsin Department of Justice as part of a background check, remains confidential. (Sec. 118.19(10)(f), Wis. Stats.)

f) Verification of completion of Human Relations Requirements. Requirements will be completed through practicum hours.

g) Satisfactory completion of COEHS PEP Admission One portfolio.

5) When students have officially transferred to UWO, they will be expected to meet all additional requirements including licensure requirements defined by PI 34, designated coursework, field experiences, assessment requirements, grade point average requirements in cumulative, professional, major, and minor, including Admission II and Exit Portfolios in completion of the program.

NOTE: Once admitted to the COEHS PEP and prior to student teaching, students will also need to pass the PRAXIS II: Subject Assessments for their licensure areas.

### **Additional Conditions:**

The following conditions will also govern the transfer agreement:

Program-to-program transfer courses/credits are accepted only for the BSE degree in Elementary Education Early Childhood to Middle Childhood (EC-MC) or for Dual Licensure in Early Childhood/Early Childhood Special Education (PreK-Grade 3 and Special Education Birth-Age 8. Any candidate who decides to change to another area or field must meet all requirements in that licensure area or program.

- 1) Any candidate who decides to complete a program outside the COEHS must meet those program requirements including general education requirements.
- 2) *The maximum number of general education semester credits that can be transferred from WTCS to UW Oshkosh is 30.*
- 3) This agreement is subject to an annual review or sooner if either school revises the curriculum. Both parties must mutually agree upon specific changes in this transfer agreement. Each campus is responsible for keeping the other informed about substantive changes in their programs that might impact this agreement. The school initiating curriculum revision(s) must notify the other school in writing, at least 30 days before the revision(s) go into effect, to the following administrator:


**Each school is responsible for keeping its instructional and advising staff fully informed of any changes in this agreement.**

- 4) The degree from WTCS must be posted on an official transcript to receive recognition from UW Oshkosh COEHS PEP. Students who have transferred to WTCS with coursework completed at other institutions will also need to provide official transcripts from those institutions.
